### Additional notes or medication identified from interview

- Patient has a satisfactory understanding of his medications and their indications.
- No apparent issues with compliance noted. Patient has trouble opening Rivotril bottle and transfers the tablets to another unlabelled container.

### Medications not on GP list

- Magmin Magnesium 1 tablet morning. No recent blood test results and dose which patient is taking is sub-therapeutic. No reports of cramping at night. Patient however still happy to take current dose of magnesium.
